Action on the bond may be brought in the name of the city to the use of the aggrieved person. Such bond must be approved by the city attorney, both as to form and as to the responsibilities of the sureties thereon. Service of Process: Before any license as herein provided shall be issued for engaging in business as a peddler or itinerant merchant in this city, the applicant for such license shall file with the city clerk as instrument nominating and appointing the city clerk his true and lawful agent with full power authority to acknowledge service of notice of process for and on behalf of said applicant in respect to any matters contained with or arising out of the business transacted under said bond, or for any breach thereof, which said instrument shall also be contain reci
